ORDER:

In the reference 1st read above, Government of Andhra Pradesh & Government of Telangana have issued certain guidelines for Inter-State Transfer of Government employees between the State of Andhra Pradesh and the State of Telangana on spouse/mutual grounds for local cadre employees (District/Zonal/Multi Zonal Cadre) and State cadre employees where the final allocation has been notified by the Central Government.

2. In the reference 2nd read above, the Joint Director of Prosecutions, Andhra Pradesh, Vijayawada has submitted proposal for Inter State transfer of Smt.K.Vijayasudha, Assistant Public Prosecutor, JMFC Juvenile Court, Kurnool (Zone-IV) and Sri M.Subbaiah, Assistant Public Prosecutor, JMFC Court, Alampur, Mahaboobnagar District, from Andhra Pradesh to Telangana and vice versa on mutual basis

3. In the reference 3rd read above, Government of Andhra Pradesh have forwarded the applications of Smt.K.Vijayasudha, Assistant Public Prosecutor, JMFC Juvenile Court, Kurnool (Zone-IV) and Sri M.Subbaiah, Assistant Public Prosecutor, JMFC Court, Alampur, Mahaboobnagar District, for their inter-state transfers from Andhra Pradesh to Telangana and vice versa on mutual basis and requested the Government of Telangana to convey their concurrence.

4. In reference 4th read above, Government of Telangana have issued “No Objection” for inter-state transfer of Smt.K.Vijayasudha, Assistant Public Prosecutor, JMFC Juvenile Court, Kurnool from Andhra Pradesh to Telangana, vice Sri M.Subbaiah, Assistant Public Prosecutor, Telangana to Andhra Pradesh on mutual basis in relaxation of para-6(g) of the Circular Memo No. 9940/SPF&MC/2015, dt.07.08.2017, subject to taking last rank next to the last regular candidate in the new State and forego seniority in the existing State as well as lien and requested to issue necessary orders for relieving Smt.K.Vijayasudha, Assistant Public Prosecutor, JMFC Juvenile Court, Kurnool from the State of Andhra Pradesh.

5. After careful examination of the proposal, Government hereby order for interstate transfer of Smt.K.Vijayasudha, Assistant Public Prosecutor, JMFC Juvenile Court, Kurnool (Zone-IV) and Sri M.Subbaiah, Assistant Public Prosecutor, JMFC Court, Alampur, Mahaboobnagar District, for their inter-state transfers from Andhra Pradesh to Telangana State and vice versa on mutual basis in relaxation of para-6(g) of the Circular Memo No. 9940/SPF&MC/2015, dt.07.08.2017, subject to taking last rank next to the last regular candidate in the new State and forego seniority in the existing State as well as lien and also other conditions stipulated in Circular Memos 1st read above.

6. The Director of Prosecutions(FAC), Andhra Pradesh, Vijayawada, shall take further necessary action for relieving Smt.K.Vijayasudha, Assistant Public Prosecutor, JMFC Juvenile Court, Kurnool from the State of Andhra Pradesh, with a direction to report before the Director of Prosecutions (FAC), Telangana State, Hyderabad.

7. The Principal Secretary to Government, Home (Courts.A1) Department, Government of Telangana, Hyderabad, is requested to take further necessary action accordingly in the matter.
