**ORDER:**

In the reference 2<sup>nd</sup> read above, the Director of Prosecutions (FAC), Andhra Pradesh has requested the Government to issue notification notifying the below officers, under Sub-Section (8) of Section 24 of the Code of Criminal Procedure 1973 (Central Act 2 of 1974) as Special Public Prosecutors and Legal Advisor cum Special Public Prosecutors to enable them to conduct prosecutions in all the cases filed by the Anti-Corruption Bureau in the Courts of Special Judges for Anti-Corruption Bureau cases and such other cases filed in the courts constituted under special courts Act 2016 and the work as may be entrusted by the Director General, ACB in the State of Andhra Pradesh.

2. After careful examination of the proposal of the Director of Prosecutions (FAC), Andhra Pradesh, Government, hereby order that the Special Public Prosecutors mentioned in the Notification appended to this order shall be designated as Special Public Prosecutors to conduct the cases of ACB under the PC Act before the Special Courts mentioned against their names during their remaining tenure as Special Public Prosecutors.
3. The Special Public Prosecutors shall conduct prosecutions in the exclusive Special cases only and they shall not be entrusted with any other work even for in charge purpose, except as directed by the Government as and when necessity arises.
4. The Director of Prosecutions (FAC), Andhra Pradesh, Vijayawada, shall take necessary follow up action in the matter.
5. Accordingly, the following Notification will be published in the Andhra Pradesh Gazette:-

*In exercise of the powers conferred under sub section (8) of Section 24 of the code of Criminal Procedure, 1973 (Central Act 2 of 1974) to conduct prosecutions of Anti-Corruption Bureau cases, the Government of Andhra Pradesh hereby designate the following Public Prosecutors/Additional Public Prosecutors appointed in the Special Courts for conducting trial of offences under the said Act, 1974 as Special Public Prosecutors to conduct prosecutions in the Special Courts mentioned against their names during their remaining tenure as Special Public Prosecutors.*
