ORDER:

In the letter read above, the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad has submitted proposal for amendment to the rule 13 of Telangana State Forest Offences (Compounding and Prosecution) Rules 1969 empowering the Police Officer not below the rank of Sub-Inspector of Police to file charge sheet before the Magistrate.

2. Accordingly, the following notification shall be published in an extraordinary issue of Telangana State Gazette, Dated:10.03.2021.

NOTIFICATION

In exercise of the powers conferred by section 68 of the Telangana State Forest Act, 1967 (Act No.1 of 1967) and all other powers hereunto enabling the Governor of Telangana State hereby makes the following amendment to the Telangana State Forest Offences (Compounding and Prosecution) rules 1969:-

AMENDMENT

In the said rules:-

For rule 13, the following shall be substituted namely:-

“13” Where an order of Prosecution is passed under below Rule 12, a Forest Officer not below the rank of a Forester authorized in this behalf or the Manager of a Primary Marketing Society, under the administrative control of the Girijan Co-operative Corporation Ltd., the officer so authorized or such Manager of the Primary Marketing Society, under the administrative control of the Girijan Co-operation Ltd., as the case may be, any police Officer not below the rank of Sub-Inspector of Police shall file a charge-sheet in Form-F before the Magistrate having Jurisdiction or the Authorized Officer.
