ORDER

In the G.O. 1st read above, the order of Precedence to be observed at all State Functions in Andhra Pradesh was issued in supersession of all previous orders/ instructions on the subject.

In the reference 2nd and 3rd read above, the Advocate General, High Court of A.P. and the State Public Prosecutor, High Court of A.P., Amaravathi have requested to place the State Public Prosecutor, High Court of AP , under Article 25 of the Warrant of Precedence at next to the Advocate General and to issue amendment orders to that effect stating that the State Public Prosecutor, High Court of AP is a statutory appointment and the State is represented by the Advocate General in Civil and other general matters whereas the Public Prosecutor represents the State in all Criminal matters.

The Government, after careful examination of the matter, hereby decided to assign the placement to the State Public Prosecutor, High Court of Andhra Pradesh under Article 25 at next to the Advocate General of A.P., in the State Warrant of Precedence, duly amending the G.O.Ms.No. 59, General Administration (Protocol.A) Dept., Dt.11.04.2018.

4. Accordingly, the following amendment is issued to the annexure of the G.O.Ms.No. 59, General Administration (Protocol.A) Dept., Dt.11.04.2018:
