ORDER:

If they fail to join the promotion post within the stipulated period of (15) days or evade joining the post by proceeding on leave or otherwise, they shall lose their promotion right / offer for the current panel year in terms of rule 11(b) of the Telangana State & Subordinate Services Rules, 1996 read with G.O.Ms.No.145, General Administration (Ser.D) Department, dated:15.06.2004.

4. The Director of Prosecutions (FAC), Telangana State, Hyderabad, is requested to take further necessary action in the matter.
