TIRUMALA TIRUPATI DEVASTHANAMS - AMENDMENT TO THE TIRUMALA TIRUPATI DEVASTHANAMS EMPLOYEES SERVICE RULES, 1989 - IN RESPECT OF QUALIFICATIONS FOR THE POST OF DEPUTY DEVASTHANAMS LAW OFFICER - FINAL NOTIFICATION.

NOTIFICATION

In exercise of the powers conferred under sub-section (3) of section 106 and sub-section (4) of section 107 read with section 153 of the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Act, 1987 (Andhra Pradesh Act 30 of 1987), the Governor of Andhra Pradesh hereby makes the following amendments to the Tirumala Tirupati Devasthanams Employees Service Rules, 1989 issued in G.O.Ms.No.1060, Revenue (Endts.I) Department, dated the 24th October, 1989 and published in the rules supplement to part-I, Extraordinary of the Andhra Pradesh Gazette, dated the 26th October, 1989 and the same having been previously issued in G.O.Ms.No. 360, Revenue (Endts.III) Department, dt.23.11.2020 and as required under sub-section (1) of section 153 of the said Act.

AMENDMENTS

In the said rules, in Annexure-II, in the table, under the heading "I.GENERAL ADMINISTRATION" at Sl.No.(10A), for the entries in columns (3) and (4) against the post "Deputy Devasthanams Law Officer" in column (2), the following shall be substituted, namely,
