ORDER:

In the circumstances of inserting section 25-A of the Code of Criminal Procedure, 1973 by amending the Cr.P.C (Amendment) Act, 2005 (Act No.25 of 2005), the Government of Andhra Pradesh hereby amend the Rule-3 of the A.P. State Prosecution Service Rules, 1992 in supersession of the orders issued in G.O.Ms.No.24, Home (Courts.A) Department, Dated:04.02.2020.

2. Accordingly, the following Notification will be published in the Extraordinary issue of the Andhra Pradesh Gazette, dated:15.06.2021.

NOTIFICATION

“In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the amendment to section 25-A of the Code of Criminal Procedure, 1973 and in supersession of the orders issued in G.O.Ms.No.24, Home (Courts.A) Department, Dated:04.02.2020 the Governor of Andhra Pradesh hereby make the following amendment to the Andhra Pradesh State Prosecution Service Rules, 1992 issued in G.O.Ms.No.188, Home (Cts.C) Department, Dated: 30.03.1992”.

AMENDMENT

In Rule 3 of the said Rules, in the table in column (2) against category (1), for the existing entry, the following entry shall be substituted namely:

“(1) A person shall be eligible to be appointed as Director of Prosecutions only, if he has been in practice as an advocate for not less than ten (10) years and such appointment shall be made with the concurrence of the Chief Justice of the High Court”.
